About You

Ideally you would have experience in the construction industry and application of the Safety, Health and Welfare at Work



(Construction) Regulations 2013. You will have a strong, yet pragmatic safety culture with excellent client management skills. You will be comfortable & confident overseeing all health & safety within the company.

The successful candidate will have detailed knowledge of ISO standards, 9001, 14001 & 45001, internal auditing processes and proficiency in written and oral English language, exceptional communication, and interpersonal skills. Applicants must demonstrate a high degree of attention to detail and ability to deliver on multiple projects with different deadlines simultaneously. A high level of IT literacy is also required, including advanced Word, Excel, and PowerPoint skills.

The role would be ideally suited to someone with marine experience or those with experience working on construction of wind farm developments in Ireland or elsewhere who is interested in diversifying to the offshore sector.
